A Resource for Trainers

Explanation for trainers, educators, social workers, counselors, and others using *HomeWork* to prepare parents and those in parenting roles for success as their child/children's teachers in the home.

Recommendations & Directions for Use

Prior to offering the training, using *HomeWork*, review the Participant Survey with participants.

- **1.** Read the "Guiding Thoughts" section together.
- **2.** Consider questions and comments.
- **3.** Ask participants to complete the survey (10 minutes at most) and return it to the trainer(s).

After the forms have been collected, the trainer(s) review and summarize the results of the completed surveys.

- **1.** The trainer should be prepared to share an informal profile of the participants as a part of the introduction or opening.
- **2.** The profiles of the training group participants will vary (e.g., by age, gender, ethnicity, interest, role, goals, purposes).
- **3.** Data collection, review, and discussions through completion of the survey may serve as a resource for educators using *HomeWork* to effectively guide parents.
